**NOMINATIONS FROM A/DCCW PRESIDENTS ARE TO BE SENT TO FCCW CHAIR – SISTER ANNA MAE FRENZIK BY MAY 1<sup>ST</sup>. A cover letter must accompany each A/DCCW nominee.**

**Nominee qualifications for this award: A woman of faith and vision that is/was actively involved in Council. A woman who serves/served Council faithfully. A woman who is giving or has given of her time and her God given gifts.**

Nominee's Councils should list their involvement (offices held, etc.) in 100 words or less and include why does A/DCCW nominate these women.

**April 1<sup>st</sup> – deadline for nomination into the hands of A/DCCW presidents**

**May 1<sup>st</sup> – deadline for nominations into the hands of FCCW Chair**
