CREDENTIAL DEADLINE MUST BE POSTMARKED BY March 13, 2026

Article X, Section 1 of the St. Petersburg Diocesan Council of Catholic Women By-Laws states, "In part, the Council shall meet annually at Convention to transact such business as shall come before it..."

In odd-numbered years, new SPDCCW Officers are elected at Convention. Voting delegates are current members of the St. Petersburg Diocesan Council of Catholic Women Board of Directors and two representatives from each Affiliate in good standing. Stamped Credentials are required to vote.

Affiliate presidents should assure that two of their members represent the Affiliate at Convention by selecting delegates who will be attending Convention and by completing and submitting the form at the bottom of this page postmarked or emailed by March 13, 2026 deadline.

Keynote Speaker – David Sonborn

David studied Music-theatre at Wheaton College, Biblical Greek at Liberty University and earned a Master's degree in Theology from the Augustine Institute.

Formerly a Protestant pastor, David was received into the Catholic Church in 2017. He has spoken and sung at Conferences and parishes throughout the U.S.. He has been featured on EWTN, the Catholic Channel, the Hallow App, the Ascension App, the Amen App and various other Catholic radio shows and podcasts.

David serves as the Director of Evangelization and Stewardship at Our Lady of the Rosary Catholic Church in Land O' Lakes. He often ministers alongside his wife, Victoria Sanborn (who holds a Master's degree in theology from the Dominican House of Studies), but their favorite ministry is to their three little boys.

Guest Speaker – Denise Mercado

She is an award winning author, blogger, solo traveler, widow, mother and grandmother. She was born and raised in Brooklyn, New York and Plainview, Long Island. As a military spouse she lived in many cities around the USA and abroad. Denise writes about her faith and all that she has learned and experienced in life. In addition to the Nihil Obstat, her books have received awards from prominent organizations such as the Catholic Media Association and the Independent Author Network. Denise has a Bachelor of Science from Campbell University, is an active member of Saint Luke the Evangelist Catholic Church in Palm Harbor, Florida, and an Associate with the Sisters of Notre Dame. As a solo traveler, Denise explores the beauty and history of the Catholic Church and share her experiences on her Catholic Travel Blog.

Guest Speaker – Kelli Crabb

Kelli Hanley Crabb is a cradle Catholic. She and her husband have been married for 48 years, but it wasn't an easy road. They met in college and he was not Catholic, but her priest advised her not to force him to convert and to let it be his decision.

Shortly after marrying Roger, at only 20 years old, Kelli was diagnosed with ovarian cancer. After a hysterectomy they adopted two beautiful children (now grown). As her priest predicted, Roger became Catholic 16 years after their wedding, and they have been members of Holy Family Catholic Church for the past 35 years.

About 5 years ago, Kelli's cancer came back in a different location she began treatment but struggled with what the chemo was doing to her body. Roger convinced her to talk to their pastor Father Bob Romain, who suggested that she pray about it. After much soul-searching, she decided to continue fighting.

Kelli admits that there were times when she questioned God, but her faith has kept her going. She firmly believes that God is granting her more time to do good things for Him.

2026 Proposed By-Law Changes

2026 Proposed Amendment to Article I - Name

Existing Bylaw:

Article I - Name

Section 1.

This organization shall be known as the St. Petersburg Diocesan Council, of Catholic Women Incorporated (Inc), hereinafter referred to as "The Council" or "DCCW" and is divided into geographical sections known as Districts.

Proposed Amendment:

Article I - Name

Section 1.

This organization shall be known as the St. Petersburg Diocesan Council, of Catholic Women Incorporated (Inc), hereinafter referred to as "The Council" or "SPDCCW" and is divided into geographical sections known as Districts, said Districts shall be defined in the Standing Rules.

Rationale: The organization's acronym should include 'SP' to represent St. Petersburg. The geographical sections must be defined in the Standing Rules, and the Bylaws should reference the Standing Rules as the source for those geographical section definitions.

Comment: If this proposed Bylaw Amendment passes, the remainder of the Bylaws would be updated to replace DCCW with SPDCCW in every occurrence.

Submitted by Melissa "Missy" Garrett / The Bylaws Committee (recommends/does not recommend) this Amendment.

2026 Proposed Amendment to Article IV - Membership

Existing Bylaw:

Article IV - Membership

Section 1.

C. In the event there is no organized parish women's group affiliated with the Council, individual membership shall be available on application to either the District President or the Diocesan President. An individual member shall be eligible to hold office and have voice.

Proposed Amendment:

Article IV - Membership

Section 1.

C. In the event there is no organized parish women's group affiliated with the Council, individual membership shall be available on application to either the District President or the Diocesan President. An individual member shall be eligible to hold office, ~~and~~ have voice and vote at the SPDCCW Annual Convention.

Rational: With the growing loss of Affiliate membership, it would be prudent to allow Individual Members to have the right to vote to increase awareness of the Mission Statement of the St Petersburg Diocesan Council of Catholic Women. "The National Council of Catholic Women (NCCW) mission is to support, empower, and educate all Catholic women in spirituality, leadership, and service, acting through its members to provide Gospel-based responses to the needs of the Church and society in the modern world." Without a viable voting population and knowledge of the existence and importance of the SPDCCW organization we will fail. Since we

follow NCCW Mission Statement we should follow NCCW Voting privileges for Individual Members.

Comment: Under NCCW: Membership and Dues/ Rights and Privileges

Voting Rights: Individual members in good standing (current on dues) are each granted **one** vote in matters brought before the general membership, such as at the annual convention. High school/collegiate individual members do not have voting privileges.

The bylaws distinguish between individual members and affiliated organizations, which are local, diocesan, or parish Catholic women's groups. While individual members get one vote, affiliated organizations receive two votes. Presidents of affiliates who are also individual members must log in separately for each membership to cast their respective votes.

If a member is in a parish whose district is inactive, she may become an individual member in another district.

Rationale:

1. Removing the phrase "if their bylaws allow" aligns with Article XIII, Section 2, which states: "These Bylaws shall govern the Districts with the provision that the District may establish Special Rules of Order and/or Standing Rules pertaining to their needs."
2. If a member belongs to a parish within an inactive District, allowing her to join as an individual member in another active District ensures she retains full participation in the Council. This provision upholds her right to membership and engagement, despite the inactivity of her original District, and supports inclusivity and continuity within the organization.
